Audrey Alejandro is Assistant Professor at the Department of Methodology, London School of Economics and Political Science. Her work focuses on discourse and knowledge, the role they play in society and world politics, how scholars can apprehend their effects and what it takes to produce discourses and knowledge that helps to create a world consistent with our socio-political objectives and values. She is the author of Western Dominance in International Relations? The Internationalisation of IR in Brazil and India (Routledge, 2018), co-convenor of the research group DoingIPS, chair of the British International Studies Association working group 'IR as a social science', and co-editor of the book series Trends in European IR Theory (Palgrave).

Ersel Aydınlı is Executive Director of the Turkish Fulbright Commission and Professor in the Department of International Relations at Bilkent University in Ankara. For three years he was also Chair of the IR Department. A former government officer in Turkey, Dr. Aydınlı completed his Ph.D. at McGill University (Montreal), and a post-doctorate at Harvard University's Kennedy School of Government. He has taught at McGill, Middle East Technical (Ankara), and the George Washington University. His areas of research interest include international relations theory, globalization and security, terrorism, and Turkish domestic and foreign politics. He has published in such journals as Foreign Affairs, Journal of Peace Research, Governance, Security Dialogue, Middle East Journal, International Studies Review, and Review of International Studies. He is the author of Emerging Transnational (In)security Governance: A Statist Transnationalist Approach (Routledge, 2010) and the co-author (with James N. Rosenau) of Paradigms in Transition: Globalization, Security, and the Nation State (SUNY Press, 2005).

Filippo Costa Buranelli is Lecturer in International Relations at the University of St Andrews, UK. His research interests are International Relations theory, international history, global governance, Eurasian politics, and regionalism. He is currently Chair of the English School section at the International Studies Association. His works have been published in a number of journals and edited collections, and his latest project on the theorisation of illiberal solidarism has appeared in International Studies Quarterly. He is currently working on a long-term project investigating the formation of a regional order in Central Asia.

Olivia Ding is a member of the "Global Pathways" project, which analyzes manually-catalogued data in an effort to better understand the structures of global International Relations. She has a Master of Arts in Political Science from the University of North Carolina at Chapel Hill. Olivia is also interested in norm transformation and diffusion, collective identities, and multilevel governance.

Charalampos Efstathopoulos is Lecturer in the Department of International Politics at Aberystwyth University, Wales, UK. He is the author of Middle Powers in World Trade Diplomacy: India, South Africa and the Doha Development Agenda (2015). His research focuses on Southern middle powers and economic diplomacy, and has been published in Global Society, International Politics, Politikon and Third World Quarterly.

Onur Erpul is Post-Doctoral Researcher at the Center for Foreign Policy and Peace Research, and the Assistant Managing Editor of All Azimuth: Journal of Foreign Policy and Peace. Erpul earned his B.A. and M.A. in International Relations at Bilkent University, and Ph.D. at Florida International University. His research interests include state formation, foreign policy, and IR Theory. Erpul's works have appeared in The Journal of Southeast European and Black Sea Studies, and E-International Relations.

Yong-Soo Eun is Professor of Political Science and International Studies at Hanyang University, Seoul, and the Editor-in-Chief of the Routledge series, IR Theory and Practice in Asia. Yong-Soo is broadly interested in IR theory, pluralism in social and international studies, non-Western and Global IR, and postcolonialism. He is the author of What is at Stake in Building 'Non-Western' IR Theory? (Routledge 2018), and the co-editor of Regionalizing Global Crises (Palgrave 2014). His work has also been published in Review of International Studies, Perspectives on Politics, International Political Science Review, among other venues.

Jeremy Garlick, PhD, is an assistant professor at the University of Economics Prague in the Jan Masaryk Centre of International Studies. He specialises in China's international relations, focusing primarily on the progress and regional implementation of the Belt and Road Initiative (BRI). His first book, The Impact of China's Belt and Road Initiative: From Asia to Europe, was published by Routledge in 2020. Apart from his publications on EU-China relations and efforts at cooperation on energy security, he has also published numerous articles on a diverse range of topics related to the BRI, including China's economic diplomacy and regionalising foreign policy. These publications include papers on the China–Pakistan Economic Corridor (CPEC), China's economic diplomacy in the Czech Republic, China's strategic hedging in the Persian Gulf, China's normative power drive in Central Asia, and China's relations with India. Dr Garlick has taught and lectured for two decades at institutes of higher education in Asia and Europe including the University of the Chinese Academy of Sciences (UCAS) in Beijing and Ewha Womans University in Seoul.

Hasan Hakses is a third-year Ph.D. candidate in International Political Economy at Marmara University. In 2014 he completed his double major in Political Science and International Relations, and Economics at Turgut Özal University, where he also earned his M.A. in International Economics and Finance in 2016. Since 2016, he has been working as a lecturer at Selcuk University Foreign Trade Department. He is interested in topics such as Regional Studies, International Political Economy, and Econometrics.

Peter Marcus Kristensen is Associate Professor of Political Science at the University of Copenhagen. His research lies at the intersection of the sociology of knowledge, International Relations theory, and emerging powers. His most recent project, States of Emergence, explored historical knowledge about power transitions and rising powers. His research has recently appeared in journals such as European Journal of International Relations, International Theory, International Studies Perspectives, and Review of International Political Economy.

Ali Murat Kursun is a PhD researcher at Aberystwyth University's International Politics department. Kursun received his BA from the department of Political Science and International Relations of the Faculty of Political Sciences at Marmara University, Istanbul. Kursun completed his MA at the department of International Relations of Istanbul Bilgi University with a dissertation entitled "Looking Into Sykes-Picot Order: Intra-Regional Dynamics in the Making of Modern Middle Eastern Borders". His main academic interests are English school theory, global governance, regional international societies, and theoretical analysis of Turkish foreign policy and the Middle East. He is the co-editor of Violent Non State Actors and the Syrian Civil War (2018, Springer) and his articles were published in All Azimuth, International Journal, Global Politics, International Politics, and Third World Quarterly. Kursun is the director of Istanbul-based resarch group Global Studies Platform, editor of Rising Powers Quarterly, and board member of the Association of Researchers on the Middle East and Africa (ORDAF).

Deniz Kuru is a Lecturer at Goethe University Frankfurt. His main research interests are disciplinary

history and sociology of IR, Global IR, Global Intellectual History, and cultural studies of world politics. His articles were published in Review of International Studies, International Relations, All Azimuth, Mediterranean Politics, and Global Affairs. He is the co-editor of "A Transnational Account of Turkish Foreign Policy."

Siyang Liu is an Associate Professor of Law in the Department of Social Science at Hebei GEO University and a member of Center for Czech Studies, which is one of Regional and National Research Centers of the Ministry of Education in China. Currently, she is a Ph. D. Candidate in International and Diplomatic Studies at Jan Masaryk Centre of International Studies, Faculty of International Relations at the Prague University of Economics and Business. She earned her master degree in law at the School of Political Science and Law of Hebei University. He has several major publications on Middle Powers, Rising Powers, and Turkish Foreign Policy. His recent article has appeared in International Politics and Third World Quarterly. He teaches several thematic and theoretical courses including Globalization and Regionalism, Theories of International Relations, Theories of International Political Economy and International Security.

Fangxing Qin is a PhD candidate in International Relations at the Prague University of Economics and Business and a lecturer in the School of European Languages and Cultures at Beijing Foreign Studies University. Her research focuses on China's relations with Central and Eastern Europe (CEE), particularly in China-Czech relations Cultural Exchange between China and Czechia in the Context of Belt and Road Initiative. Her research interests include relations between China and Central and Eastern Europe Countries, Belt and Road Initiative and Cooperation between China and Central and Eastern European Countries (17+1 Cooperation), relational theory and Global IR.

Dr. Erkam Sula specializes in the study of foreign policy and research methodology in social sciences. He is currently working on the application of computer assisted methods in data collection. His research combines event data analysis with content analysis to observe the parallelism of words and deeds in foreign policy. As part of his PhD research at Bilkent University, Erkam collected data about Turkey's foreign policy words and deeds. As a result of this data collection process he developed the Turkish Foreign Policy Roles and Events Dataset (TFPRED) which contains data gathered from Turkish leaders' speeches and 36.000 International news reports. Erkam, holds an 'International Relations' PhD degree from Bilkent University. In 2018-2019, Dr. Sula continued his studies on research methods as a visiting post-doctoral fellow at Harvard University Institute for Quantitative Social Science. His post-doctoral research at Harvard IQSS was funded by the Scientific and Technological Research Council of Turkey. He has previously published on Role Theory, Event Data, Middle East, Turkish foreign policy and

eclectic methodology in foreign policy analysis. Dr. Sula is currently a faculty member at Ankara Yildirim Beyazit University, Faculty of Political Science.

Dr. Wiebke Wemheuer-Vogelaar is post-doctoral researcher at the DFG-funded project "Global Pathways: Knowledge Diffusion in International Relations research" at Freie Universität Berlin. She has been an active contributor to debate on global IR, with several publications on the topic in peer-reviewed journals and edited volumes.
